HOUSE RULES

- _____ 1. Everyone must show their membership card when requested.
- _____ 2. Bar tenders have the authority to refuse service to members for just cause. Bar tenders have the right to order anyone off the premises for just cause.
- _____ 3. No saving of seats at the bar.
- _____ 4. No person under the age of 18 is to be seated at the bar.
- _____ 5. Members are responsible for their guests. Guest(s) must leave with the member who signed them in. All guests MUST be signed in. Guests are limited to three (3) visits. After the 3rd visit, the guest must become a member, if eligible.
- _____ 6. No post business discussed in the canteen. This includes complaining about the operations of the canteen or kitchen. If you have concerns about their operations, please submit a complaint in the complaint box or write a letter to the Post Executive Board or bring up your concern in a post meeting.
- _____ 7. Proper attire is to be worn. This includes, but is not limited to, clothing that is too revealing, contains derogatory or inflammatory language, gang or motorcycle club colors. There may be exceptions to this policy concerning the wear of motorcycle "colors" for post sanctioned biker events. This rule does not apply to the American Legion Riders gear.
- _____ 8. No abusive, threatening, or disruptive language or behavior. This includes but is not limited to cursing, racial slurs, or any type of derogatory or inflammatory language. (You may receive a verbal warning, but after that the consequences for violations of this rule will start as follows, but not necessarily be limited to: 1st Offense – you will be kicked out for the day; 2nd Offense – kicked out for one week, 3rd offense – kicked out for one month)
- _____ 9. NOBODY is allowed behind the bar except the on-duty bar tender and the canteen manager. If you need to go behind the bar for any reason, and you are not the on-duty bar tender or the bar manager, you MUST ask permission from the on-duty bar tender.
- _____ 10. Possession and/or use of illegal drugs on Post Property is prohibited. (Marijuana use on Post 30 property is strictly prohibited)
- _____ 11. Smoking, use of smokeless tobacco (chew, dip, etc), and/or the use of electronic cigarettes or vaping devices is prohibited indoors.
- _____ 12. No outside food or beverages unless approved by the canteen manager, kitchen manager or canteen committee chairman.
- _____ 13. No political or religious discussions at the canteen.
- _____ 14. All members are expected to use their keycard for entry to the canteen. Any members failing to use their keycard may face loss of canteen privileges. If you have lost your keycard, a new keycard can be purchased at the canteen.
- _____ 15. The use of the Post 30 Canteen is a privilege. The Executive Board reserves the right to bar a member from the canteen for violations of these House Rules or due to behaviors/actions of persons who do not contribute to the well-being of our Post.
